NO FEE REQUIRED:

The Australian Disability Parking Permits are now fully funded by the State Government.

The ACROD Parking Program will only issue an Australian Disability Parking Permit to a taxi owner who is registered and is the holder of a current taxi plate with the Department of Transport, Western Australia. When you sign and submit your application you are agreeing to allow us to check your details and taxi plate registration with the Department of Transport, WA.

The Australian Disability Parking Permits can only be used when transporting an eligible person who is exiting or entering the vehicle. To be eligible:

- A person must be unable to walk and always requires the use of a wheelchair;
- or
- A person's ability to walk is severely restricted by a permanent medical condition or disability;
- or
- A person's ability to walk is severely restricted by a temporary medical condition or disability.
